1. COMPLETION PERIOD:-

The entire contractual period under scope of work shall be of two years from date of start of work/contract.

2. EARNEST MONEY

- 2.1 The tender must be accompanied with an Earnest Money of Rs 20,000/- (Rupees Ten Thousand only) failing which the tender will be outright rejected.
- 2.2 Uploaded Bid must be accompanied with scanned copy of receipt towards the Cost of Tender and Earnest Money.
- 2.3 Tender Document fee (non-refundable) & Bid Processing Fee (non- refundable) will be accepted by Online only. Tenders submitted without Tender Fee shall not be accepted.
- 2.4 No Earnest Money will be accepted after due date & time of physical submission.
- 2.5 The Earnest Money deposit will be refunded to each of the unsuccessful bidders on application. In case of successful Bidder, it will be retained till submission of Performance Guarantee. No interest on Earnest Money will be payable.
- 2.6 In the event, the successful Bidder fail to sign the contract agreement with BHPC within one week after receiving notice of award of contract and fail to submit a Performance Guarantee as specified in this document, the Earnest Money Deposit will be forfeited to compensate damage caused to BHPC. The Earnest Money of the successful bidders shall be returned after they will furnish the Performance Guarantee.
- 2.7 The Earnest Money shall be furnished in a separate sealed cover and scanned copy shall accompany with the Techno-commercial part of the bid.
- 2.8 Any bid/tender not accompanied with Earnest Money will be rejected as being non responsive.
- 2.9 This Earnest Money is required to protect the rights of the BHPC against the risk of the bidder's conduct which would warrant the Forfeiture of the Earnest Money under the conditions detailed in the specification.

5. ELIGIBILITY & QUALIFYING REQUIREMENT

Technical mandatory criteria:

Technical Qualification Criteria for the Bidder:

The invitation of bid is open to all agencies, firms, companies, consultants, State Government and Central Government agencies, who meet the requisite qualifying requirements stipulated herein under and the bidder shall provide satisfactory evidences that it:

- a. The Bidder should be in Consultancy Business of Power Sector since last 15 years as on the date of submission of bid which should be evidenced from the Certificate of Incorporation and must have clear understanding of the Indian regulatory and accounting framework in power sector and developments over the last decade including the applicable policies, legal and regulatory framework and reforms at Central and State levels and should have adequate technical knowledge and experience of generation, transmission and distribution of electricity and financial analysis and accounting.
- b. The Bidder should be registered in India with appropriate statutory authorities as required under law. Copies of all such registration papers including PAN, GST, Certificate of Incorporation, etc. must be enclosed.
- c. The Bidder should have adequate financial capability and status to meet the financial obligations pursuant to the services covered in the Tender document. The Bidder shall have average annual turnover of at least Rs. 10 (Ten) crores from consultancy business in power sector in India during the last 03 financial years i.e. up to FY 2023-24 which should be evidenced by certificate from the statutory auditor and extract of statutory

audited accounts.

- d. The Bidder must have completed at least one (1) tariff / regulatory assignment for government owned hydro power generating company of at least Rs. 25 lakhs (Twenty-Five lakhs) value in the past 7 financial years which is to be evidenced by work completion certificate.
- e. The Bidder must have completed at least three (3) tariff / regulatory assignments for government owned Generation/ Transmission/ Distribution Utilities or Evaluation & Analysis of ARR petitions for CERC / SERC / JERC of at least Rs. 25 lakhs (Twenty-Five lakhs) value in the past 7 financial years which is to be evidenced by work completion certificate.
- f. The Bidder shall be well acquainted with the Regulatory environment in the power sector, and functioning of licensees / generating companies of Central or State Companies / Central or State Regulatory Commission or other Central / State or other Regulatory Authorities and possess experience in dealing with such similar matters on a wide range.
- g. The Bidder should have minimum 50 employees on PAYROLL in Power Consultancy business.
- h. Bidding is open to individual bidder only and no subcontracting, consortium or Joint venture is permitted.
- The Bidder including its affiliates/associates/directors/subsidiary company(ies) must not be suspended / blacklisted / debarred by any PSU / Centre or State Government Department / Financial Institution / Courts as on the date of issuance of this tender. The Bidder shall submit an undertaking on a notarized affidavit of Rs. 100 against the same.
- j. The Bidder including its affiliates/associates/directors/subsidiary company(ies) should have, during the last three years, neither failed to perform on any agreement, as evidenced by imposition of a penalty by an arbitral or judicial authority or a judicial pronouncement or arbitration award, nor have been expelled from any project or agreement nor have had any agreement terminated for breach. The Bidder shall submit an undertaking on a notarized affidavit of Rs. 100 against the same.

6. SUBMISSSION OF TENDER

- i. The bidder shall submit his bid/tender on e-Procurement platform at www.eproc2.bihar.gov.in.
- ii. The bidder must have the Class 11/111 Digital Signature Certificate (DSC) with signing+ Encryption, and User-id of the e-Procurement website before participating in the e-Tendering process. The bidder may use their DSC if they already have. They can also take DSC from any of the authorized agencies. For user-id they have to get registered themselves on e-procurement website www.eproc2.bihar.gov.in and submit their bids online on the same. Offline bids shall not be entertained by the Tender Inviting Authority for the tenders published in e-procurement platform.
- iii. The bidders shall submit their eligibility and qualification details, Technical bid, Financial bid etc., in the online standard formats given in e-Procurement web site at the respective stage only. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., in support of their eligibility criteria / technical bids and other certificate / documents in the e-Procurement website. The bidder shall digitally sign on the supporting statements, documents, certificates, uploaded by him, owning responsibility for their correctness / authenticity. The bidder shall attach all the required documents for

the specific tender after uploading the same during the bid submission as per the tender notice and bid document.

- iv. All the required documents should be attached at the proper place as mentioned in the e-forms otherwise the tender of the bidder will be rejected.
